What is OSTC?

Through Pennsylvania's Opportunity Scholarship Tax Credit Program (OSTC), businesses can direct their state tax dollars to scholarships for students stuck in the state's worst schools, enabling them to attend great schools like St. James School. Your business' scholarship dollars provide a life-changing education for students from one of the poorest neighborhoods in the city.

HERE'S HOW IT WORKS

Any business that pays any type of PA state taxes is eligible - including pass-through organizations, LLCs, S-Corps, C-Corps and more. Make a 1-year commitment and receive a 75% tax credit...a 2-year commitment gives you a 90% tax credit.

The process is easy!

- 1 Estimate your PA tax liability for the year.
- 2 Complete a 15-minute application online—we can do this for you!
- 3 Once you are approved, make a gift to St. James School.
- 4 Your credit is automatically applied to your state tax bill.

Example: Make a \$10,000 donation and receive a 90% tax credit of \$9,000.*

*Note: Your donation is also fully tax-deductible on your federal taxes, providing more savings!
